5. Public Hearing: Wireless Telecommunications Facilities Code

Introduced by Community Development Director Anne Johnson and presented by Ken Fellman from Kissinger & Fellman, P.C. on a consideration of repealing and replacing Section 30-3-111 of the Berthoud Municipal Code to update the Wireless Communications Facilities Code Ordinance 1325 (2023).

6. Public Hearing: Amendment to Chapter 30 of Berthoud Municipal code (Land Development)

Community Development Director Anne Johnson introduced proposed amendments to the following Sections of Chapter 30 of the Berthoud Municipal Code: 30-1-116 regarding the definition of storage containers as storage units and Marijuana Businesses (also Sections 30-3-111, 30-3-112, 30-1-117 and 30-3-104); and clarifying land use application processing requirements throughout Chapter 30 via Ordinance 1326 (2023).

Lynn Larsen has a role with the alcohol & marijuana board and wanted to point out that the terminology in the Town Code should reflect terminology in the State regulations.

- **Section 6, Table 1.1 to insert the final terminology for marijuana facilities into the land use table.**
